

Twenty-Sixth Annual Passover/Feast of Unleavened Bread -- 6009/2006

"The Seven Last Plagues," Part 6

Praise יהוה! Praise יהוה בניהוה! I ask that all of you who are present today stand up and give your sincere exaltation, exclamation, and joyfulness for the One True and Living God, your and my Father, יהוה! For it is our God, יהוה, who is most lofty, omnipotent, omnipresent, magisterial, aristocratic, and immortal. Moreover, rejoice in knowing that all of these distinct characteristics have been passed down to the Son of יהוה who is on the planet Earth this day in the flesh and blood body of a man whose name is יהוה בניהוה. Yes, יהוה בניהוה is the only physical manifestation and representation of the Father, יהוה, that we will ever see or know; therefore, we are tremendously blessed and fortunate. Praise יהוה!

יהוה בניהוה is the only Man that stood up when the question concerning the downtrodden and oppressed so-called Black people of America was asked. יהוה בניהוה was the only one who magnanimously and selflessly volunteered Himself to come down from His place in heaven with His Father, יהוה, and said, "Here am I, יהוה, send Me," as validated in Isaiah, Chapter 6, verse 8. And He, יהוה בניהוה, is still, to this very day, being bruised and suffering for

us, His chosen people from the Tribe of Judah (Yehuwdah) and the entire world. But fret not, for יהוה בן יהוה shall be restored to His rightful place as King and Ruler of all things in heaven and earth. So rejoice exceedingly, Israel, for the day of יהוה בן יהוה is near at hand: The great day when we shall behold His amazing glory as the Only Begotten Son of the Father, יהוה . Praise יהוה and יהוה בן יהוה forever!

Shalom Aleichem, be eternally blessed, and welcome to this grand occasion known as the Twenty-Sixth Annual Passover and Feast of Unleavened Bread for the Nation of יהוה in the solar year of our Lord, יהוה בן יהוה , 6009. Your presence at this place--the Hutchinson Island Marriott Beach Resort and Marina in Stuart, Florida, where יהוה has chosen to place His holy and righteous name--testifies that you are in accord with the divine laws of יהוה . This great feast commemorates the event during which our God, יהוה , delivered our forefathers out of the land of Egypt in haste after passing over their houses and sparing their lives from His angel of death who passed through the land of Egypt and smote all of the firstborn (Exodus, Chapter 12). Praise יהוה !

Today's seminar discussion is "The Seven Last Plagues," Part 6. Following the same protocol and outline of our previous seminars, we shall endeavor to

shed a very bright light on the particularity and correct circumstances regarding the pouring out of the vial of the wrath of יהוה which contains the third of the seven last plagues. But before we move on, we will review some of the astounding information that we were privileged to learn in our last seminar.

Firstly, the knowledge that we received was gained from our decoding of the foundation research Scripture located in the Book of Revelation, Chapter 16, verse 3, which reads:

"And the second angel poured out his vial upon the sea; and it became as the blood of a dead man: and every living soul died in the sea."

This Scripture delineates the harsh and disastrous fate that shall befall a specific group of people. We began our explanation by pointing out that this plague shall be carried out by the second of the seven angels of יהוה. This second angel shall come after the first angel in the series of seven angels, and he shall follow the one that comes before him in pouring out his specific plague upon the inhabitants of the earth.

In our foundation Scripture, this second angel of יהוה poured out his vial upon the sea. Therefore, by defining the word pour we were able to determine that the second angel shall gush out, run greedily out, spread abroad, spread forth, and spill the contents of his vial--the second vial--of the wrath of יהוה upon the sea.

We confirmed that word his as it relates to this Scripture is a possessive adjective showing the possessor of the vial. Hence, we concluded that the angel in this verse is the possessor and carrier of the second plague. Moreover, this angel is the agent by which a specific action--the pouring out of the second vial of the wrath of יהוה--shall be fulfilled.

We revealed once again that the object the second plague shall be poured out of is called a vial, which is a broad shallow cup. Broad was described as being full and open. And shallow was determined to mean of little depth. We previously found these interpretations to mean that this full and open cup will be of little depth, thereby, meaning that it will be very easy for the contents to pour out. Lastly, we learned that the cup being mentioned is one's portion or share, as of sorrow.

Accordingly, we were able to affirm that this second vial of the wrath of יהיה, in the possession of the second angel, will be full and open of the portions or shares of sorrow that shall be easily poured out upon the inhabitants of the "sea." This brought us to the point where we divulged and brought out into the open the truth regarding "the sea," which the Scripture identified as the recipient of this second plague.

We showed that we were not speaking about the physical seas and bodies of water that make up most of the earth by referring to the Greek dictionary of *The New Strong's Expanded Concordance*, where the word **sea** was located under the reference number 2281, pronounced thal-as-sah. Thalassa metaphorically spoke of the ungodly men (described in Jude, verse 13). It also referred symbolically to the state from which the beast shall arise from the midst of; it is also symbolized as the final gentile power dominating the federated nations of the Roman world.

Thus, we came to the understanding that the sea is symbolic of a group of federated nations made up of ungodly men from which the beast shall arise. It is also symbolic of the final gentile power that dominates the federated nations of the Roman world. Furthermore, we proved that a gentile is a Christian as distinguished from a Hebrew and who is also identified as a

heathen. A heathen is any member of any nation or people not worshipping the God of Israel. Federated nations were uncovered as united or joined countries and governments.

These explanations correctly described the United Nations, which has an ambassador from almost every developed country in the world. And none of them worship the God of Israel, יהוה. The word Roman was found to be of or relating to the see of Rome or the Roman Catholic Church. Therefore, we were able to conclude that the Beast or anti-Christ is set to arise from the midst of a group of ungodly Christian nations from within the See of Rome or the Roman Catholic Church, which dominates all of the federated nations of the world. These persons are distinguished from Hebrews in that they do not worship יהוה, the God of Israel; and they are in fact ambassadors to the United Nations. This group of Christians is also representative of the final gentile power that shall dominate the federated nations of the Roman world or Roman Empire.

We researched more information on the See of Rome and found out that the Roman Catholic Church is the largest single Christian body composed of those Christians who acknowledge the supreme authority of the bishop of Rome, the pope, in matters of faith. The word catholic (Greek katholikos)

was substantiated as meaning "'universal,' and has a total membership of about 1 billion (about 52 percent of the total number of affiliated Christians, or 16 percent of the world population)."

These definitions made it easy to figure out that this previously mentioned group of ungodly men, who shall have the second plague of **הַיַּיָּוֵה** poured out upon them, consists of the pope, diocese, cardinals, bishops, nuns, and clergy of the See of Rome. Though there are many denominations of the church, such as the Baptists, Methodists, Presbyterians, Episcopalians, etc., they all fall under the jurisdiction of the Roman Catholic Church.

Because the Scripture stated that the See of Rome became as the blood of a dead man, we defined the word become, which lead us to the determination that the See of Rome, the Roman Catholic Church, shall change, develop, or progress into a thing that resembles the blood of a dead man. Through making plain the word blood we ascertained that there are people whom the Roman Catholic Church considers for their potential to strengthen and improve their organization.

These people are the cardinals, bishops, priests, nuns, preachers, etc. The individual person whom the church regards as a source of vitality is the

pope. Vitality is life. However, Revelation, Chapter 16, verse 3 stated that the pope, cardinals, bishops, priests, nuns, preachers, etc.--regarded as a source of life for the church--shall become as that of a dead man.

From our former foundation research Scripture, we expressed the meanings of the words dead, declension and man. When we put all of the previously explained pieces together, we were able to formulate the statement that the pope and the persons such as the cardinals, bishops, priests, nuns, and preachers--considered for their potential to strengthen the organization of the See of Rome or the Roman Catholic Church--shall change, develop or progress into a perpetual death. Moreover, the Roman Catholic Church shall be left totally inactive and barren of not only members, but also of cash or money. Praise יהוה!

We decoded the last segment of the Scripture for complete comprehension of the Word of יהוה by making simple the statement that "... every living soul died in the sea." Every was classified as constituting each and all members of a group without exception and as the fullest possible. We learned that to be living meant to be alive. And soul was documented as "the spiritual part of humans regarded in its moral aspect, or as believed to survive death and be subject to happiness in a life to come." A living soul is also a person.

Here, we clearly deduced that all members of the See of Rome or the Roman Catholic Church, without exception, who are living souls or alive shall die. Furthermore, they shall be exterminated out of existence to the fullest extent possible. This is because their deaths shall include not just their physical bodies, but even their "spiritual" parts--their very souls. Praise יהוה!

We ended our discussion of Revelation, Chapter 16, verse 3, by learning the meaning of the word die, which is to pass from physical life. Thus, all persons and members in the See of Rome shall pass from "physical" life. To die also meant to cease to exist or vanish. And to vanish is to disappear from sight, especially quickly. Lastly, to die was revealed as "the destruction or extinction of something."

Overall, we realized that the pouring out of the second of the seven last plagues shall cause all in the Roman Catholic Church to pass from physical life and cease to exist. It shall quickly and totally disappear from sight off the planet. To die is also "to end in failure." This means that all of the teachings that have been indoctrinated into the minds of over 1 billion people around the world shall fail. The deceptive tactics that the Beast and

his empire--the See of Rome--have put into deceiving the entire world shall end in complete failure. Praise יהוה!

At this point, we are now ready to investigate and delve into the knowledge and understanding that our beloved Father, יהוה, has prepared for us today. We will achieve this by turning to and reading the foundation research Scripture for this seminar, which is Revelation, Chapter 16, verse 4. Let us read:

"And the third angel poured out his vial upon the rivers and fountains of waters; and they became blood."

By our laying bear and open the Scripture, Revelation, Chapter 16, verse 4, we are continuing the process of making known to the world, specifically those who wish to be aware and conscious of the truth, the specifics concerning some of the things that shall take place in the End Times. Nevertheless, it is left to you who partake of this message to hear and then make the necessary changes in your lives to be spared from the great wrath and vengeance of יהוה that we learned of in our earlier seminars. Praise יהוה!

The pertinent information concealed within our foundation research Scripture can only be uncovered and revealed by utilizing and applying the

divine Ten-Step Study Method of יהוה בן יהוה in order for us to come to an appropriate and complete understanding of the Word of יהוה. The plan of study we will follow shall begin with us breaking down the principal statement made in Revelation, Chapter 16, verse 4, which reads, "And the third angel poured out his vial upon the rivers and fountains of water; ..."

In this Verse, we see that it is the third angel in the series of the seven angels of יהוה that is commencing on his charge and task from יהוה. His task is to pour out his particular vial containing the third of the Seven Last Plagues upon the rivers and fountains of water. Seeing that this is the third angel to pour out his plague, we will defer to *The New Strong's Expanded Exhaustive Concordance of the Bible*, Red Letter Edition, copyright 2001, on page 253 of the Greek dictionary, under the reference number 5154, to learn that **third** in Greek is pronounced tree-tos. The number word **tritōs** is defined as "a third part or the third time."

Thus, we recognize that the angel spoken of is acting out the third part of the seven part plan in which the seven last plagues are to be enforced. He is the vessel by which יהוה shall unleash a different and separate plague for the third time upon a precise entity.

Another account of the word **third** can be vouched for in *Webster's New World Dictionary & Thesaurus*, copyright 1998, Computer Software, as "preceded by two others in a series." And the *Merriam-Webster's 11th Collegiate Dictionary*, copyright 2003, Computer Software, defines **third** as "ranking next after the second in authority or precedence." This being the case, it is apparent that two other angels in this series of seven angels who possess the seven last plagues shall precede this third angel. Further, this angel ranks next after the second angel in Revelation, Chapter 16 in authority and precedence.

Question: What significance is being placed on the person in this Scripture characterized as an angel? Well, we disclosed the essential nature of an angel in part two of this seminar series. However, that was some time ago so we will refresh our memories by once again elucidating on the power that is afforded to those identified as angels of **יהוה**.

It is authenticated in *The New Strong's Expanded Exhaustive Concordance of the Bible*, Red Letter Edition, copyright 2001, on page 158 of the Hebrew dictionary, reference number 4397, that an **angel** is spelled from right to left (Mem, Lamed, Aleph, Chaf-Sofet), pronounced mahl-ahk. Mahlahk means "to dispatch as a deputy."

On the record in *Microsoft Encarta Reference Library 2004*, copyright 1993-2003, Computer Edition, to **dispatch** means, "to instruct somebody to go somewhere to carry out a task." A task is also a charge. The angel in this Scripture has been instructed to go and carry out his charge from יהוה as a deputy. The forenamed source also affirms that a deputy is "somebody who has been authorized or appointed to act on behalf of somebody else with full authority." On this wise, we see that יהוה has authorized this appointed person or being to act on His behalf with His full authority to carry out the charge of fulfilling His third plague in the series of the seven last plagues.

An angel, still from the same source, is "a divine being who acts as a messenger of God [יהוה]." A messenger is identified as a "go-between." Hence, this divine being in Revelation, Chapter 16, verse 4 is just one in the group of seven angels in all that shall act as a go-between for our God, יהוה, to accomplish the task and charge that He has already set forth for him in the Scripture. Psalm, Chapter 103, verses 20 and 21 read:

20 "Bless the Lord, יהוה, ye His angels, that excel in strength, that do His commandments, hearkening unto the voice of His word.

21 Bless ye the Lord, יהוה, all ye His hosts; ye ministers of His, that do His pleasure."

Matthew, Chapter 13, verses 49 and 50 further state:

49 "So shall it be at the end of the world: the angels shall come forth, and sever the wicked from among the just, 50 And shall cast them into the furnace of fire: there shall be wailing and gnashing of teeth."

In our foundation Scripture for this discussion, as with all of our previous seminars, we read that the angel of יהוה shall pour out his own vial which contains a particular plague. Therefore, we shall refer back to our formerly acknowledged meanings of the words pour, his, and vial from our other seminars.

Established on the soundness of *e-Sword*, Computer Software, copyright 2000-2004, reference number 1632 of the Greek dictionary, **pour** in Greek is pronounced eh-kheh-o or eh-khoo-no and means to "gush out, run greedily out, spread abroad, spread forth, and spill." Therefore, we can resolve that the third angel shall gush out, run greedily out, spread abroad, spread forth, and spill the contents of his vial--the third vial of the wrath of יהוה --upon the rivers and fountains of water.

It was confirmed in our last seminar that in grammar, the word his as it relates to this Scripture is a possessive adjective showing the possessor of the vial. Because the word his is used in reference to the person in Revelation, Chapter 16, verse 4, we can ascertain that the angel in this verse is simply the possessor and carrier of the third plague. Additionally, this angel shall be the agent and object by which a specific action--the pouring out of the third vial of the wrath of יהוה--shall be fulfilled and consummated.

According to Revelation, Chapter 16, verse 4, the object and item that the third of the Seven Last Plagues shall be poured out of is labeled as a vial. A vial is cited in *The New Strong's Expanded Exhaustive Concordance of the Bible*, on page 263 of the Greek dictionary, number 5357 and pronounced in Greek fee-al-ay. A **phiale** is "a broad shallow cup."

Broad from *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 182, is "full and open." While **shallow** from *The New Oxford American Dictionary*, copyright 2001, on page 1566, means "of little depth." We formerly interpreted this definition to mean that this full and open cup will be of little depth, owing to the fact that it will be very easy

for the contents to pour out. And lastly, a cup from the same source is, "one's portion or share, as of sorrow."

Wherefore, we can assert clearly and irrefutably once more that the third vial, which contains the third plague of יהוה and is in the possession of His third angel, is full and open with the portions and shares of sorrow. These portions and shares of sorrow shall easily be poured out and gushed upon all the rivers and fountains of water as stated in our foundation Scripture for today.

At this time, we shall take a quick moment to read our foundation research Scripture with what we have discovered and laid open so far for the benefit of gaining a thorough perception of its true meaning. Let us read Revelation, Chapter 16, verse 4:

"[And the third angel or messenger of יהוה in the series of seven angels poured and gushed out his portion or share of sorrow] upon the rivers and fountains of water; and they became blood."

Praise יהוה! Moving steadily along, we want to ask the question: What constitutes and makes up the rivers and fountains of water in this Scripture? Let us seek to expose the facts surrounding the circumstances that shall

come about and resultantly cause these rivers and fountains of water to become blood after being devastated and annihilated by the third of the seven last plagues. Remember, we are completing our break down of the phrase "And the third angel poured out his vial upon the rivers and fountains of water; ..."

On the trusted authority of *Random House Webster's Unabridged Dictionary*, copyright 1999, Software Edition, a **river** is substantiated as "a similar stream of something other than water." It is also "any abundant stream or copious flow; outpouring." A **stream** is "something that flows continuously or quickly in large quantities," according to *Microsoft Encarta Reference Library 2004*, copyright 1993-2003, Computer Edition.

Paying close attention to these definitions is crucial because we are able to determine that the rivers mentioned in this Scripture are not physical bodies of water. The word river in Revelation, Chapter 16, verse 4 symbolically and metaphorically refers to a stream of something other than water. Plus, this stream is abundant and flows continuously or quickly in large quantities.

To find out exactly what this river symbolizes we must define it from its etymological perspective. Based on an account located in the *American*

Heritage Talking Dictionary, copyright 1997, Computer Software, **river** etymologically comes from the Latin feminine of **riparius**, which is "of a bank", and from **ripa**, plainly meaning "bank." Now, we see what the Scripture is actually speaking of. Therefore, we shall explain what a bank is and what type of services it provides.

The *Microsoft Encarta Reference Library 2004*, copyright 1993-2003, Computer Edition, certifies, "a broad definition of a bank is any financial institution that receives, collects, transfers, pays, exchanges, lends, invests, or safeguards money for its customers. Many other financial institutions are not usually thought of as banks; nevertheless, they provide one or more of these banking services. These institutions include finance companies, investment companies, investment banks, insurance companies, pension funds, security brokers and dealers, mortgage companies, and real estate investment trusts." Lastly, other terms for bank are "savings and loan association and Federal Reserve Bank."

The etymological definitions of the word river and definitions of the word bank lead us to the determination that the third angel of **יהוה** shall pour out his vial of the wrath of **יהוה** upon the abundant, continuous and quick flow of money and services provided in large quantities by the banks and financial

institutions of America and the world. Plainly speaking, this third plague shall come upon any financial institution in America or around the globe that receives, collects, transfers, pays, exchanges, lends, invests, or safeguards money for its customers.

In addition, all other financial institutions that are not thought of as banks but provide one or more of the aforementioned banking services shall also suffer from this third plague in the series of seven plagues. These institutions include finance companies, investment companies, investment banks, insurance companies, pension funds, security brokers and dealers, mortgage companies, and real estate investment trusts. Even the Federal Reserve Bank, which is the central bank that regulates funds for all of its affiliated banks in the Federal Reserve Districts in the United States, shall fall under this plague. Praise יהוה !

יהוה בן יהוה taught us for many years that the economy of America, biblically known as Egypt, shall collapse and that the money would fail. This means that the green paper we carry around in our wallets and trip out about will end up being totally worthless and useless. Let us go to the Book of Genesis and confirm this by reading Chapter 47, verse 15:

"And when money failed in the land of Egypt, and in the land of Canaan, all the Egyptians came unto Joseph, and said, Give us bread: for why should we die in thy presence? for the money faileth."

Our foundation research Scripture, Revelation, Chapter 16, verse 4 goes on to state that the third angel of **יָהוָה** poured out his vial not only upon the rivers, but also the fountains of water. Predicated in *e-Sword*, Computer Software, copyright 2000-2004, **fountain** from the Greek dictionary, under the number 4077, is pronounced pay-gay. A pay-gay or fountain is validated as "(figuratively), a source or supply (of water)."

The *New Oxford American Dictionary*, copyright 2001, prints on page 669 that a **fountain** is "a source of desirable quality." Some synonyms of **quality** taken from *The Synonym Finder*, by J. I. Rodale, copyright 1978, on page 971 are "property, stock in trade, trademark, and asset." With these explanations, we can deduce that fountains are the sources and supplies of desirable qualities in the form of properties, stocks in trade, trademarks, and assets.

So, what is water? We obviously are not talking about the water that we

drink or bathe and swim in. Well, we already clarified what the rivers stated in our Scripture actually are. And now we know that the fountains in this same Scripture refer to sources or supplies of desirable qualities; such as property, stock in trade, trademarks, and assets. For this reason, we will define the word water from a figurative point of view with regard to finances.

The Random House Webster's Unabridged Dictionary, copyright 1999, Software Edition, firmly establishes that in finance, **water** is "fictitious assets or the inflated values they give to the stock of a corporation." Furthermore, in *Merriam-Webster's 11th Collegiate Dictionary*, copyright 2003, Computer Software, **water** is "stock not representing assets of the issuing company and not backed by earning power." **Stock** from the same source is, "money or capital invested." And capital is "material wealth in the form of property or money."

This means that the abundant, continuous and quick flow of money and services provided in large quantities by the banks and financial institutions of America and the world is mostly possible because of fictitious financial assets and the inflated values they give to the stock of corporations and companies. The material wealth in the form of property and money that is

invested in these corporations and companies does not represent the actual assets they possess because it does not reflect their real or actual earning power.

So we can now comprehend that all of the money and buying power that the major Fortune 500 corporations, companies, and big businesses in America and around the world have come, in part, from their accountants and CPAs doctoring up their fiscal books and ledgers. Exaggerated assets allow these persons to acquire and collect most of their money unethically and immorally.

If you watch the news, you will notice at least one or more big business CEOs being prosecuted every month or so for embezzling funds or wrongfully selling their company stock. They are altogether a bunch of cheaters and thieves. Most importantly, it is no secret that this country (the United States) is trillions of dollars in debt and in a huge economic deficit. We constantly see major companies--like large airlines carriers--filing for bankruptcy and Chapter 11.

That being so, then you have to ask yourself, Where does all the money for these people come from? It is all "water"--not real. But that does not stop

them from wanting enormous amounts of money and material things and doing whatever they possibly can to get it. First Timothy, Chapter 6, verse 10 tells what this condition is--and it reads:

"For the love of money is the root of all evil: which while some coveted after, they have erred from the faith, and pierced themselves through with many sorrows."

Let us, at this current point in our seminar, read our foundation Scripture with the information we have gathered since we last read it. Revelation, Chapter 16, verse 4--let us read:

"[And the third angel or messenger of הוה" in the series of seven angels poured and gushed out his portion or share of sorrow upon all of the banks, financial institutions, insurance agencies, investment agencies, mortgage companies, etc. of America and the world. This includes the sources and supplies of desirable qualities; such as money, property, stocks in trade, trademarks, and assets that are fictitiously exaggerated and inflated by the major companies and corporations of America and the world in order for them to have a greater value than they should;] and they became blood."

Praise יהוה! "... and they became blood." This is the final point that we shall bring to light in today's discussion--the fact that these rivers and fountains of water became as blood. What does this mean? Physiologically, **blood** is the "red fluid that circulates in the body," according to *Microsoft Encarta Reference Library 2004*. The key word in this definition is red. All of our decoding of the Scripture so far has lead us to finance, money, and economics.

Thusly, if we are talking about things of monetary value, such as, property, stocks, trademarks, and assets becoming as blood, then it must mean that they shall become "red" or go "in the red." To prove this, we will define the word **red**. Trusting the accuracy of the *Webster's New World Dictionary & Thesaurus*, copyright 1998, Computer Software, it states that the idiom 'in the red' comes "from the practice of entering negative amounts in account books with red ink." It also means to be "in debt or losing money." Additionally, "into the red" specifies going "into debt or an unprofitable financial condition."

These definitions corroborate and confirm that the consequence of the third angel of יהוה pouring out his vial of the wrath of יהוה upon the abundant, continuous and quick flow of money and services provided in large

quantities to America and the world by all of the banks and financial institutions shall go red or into the red. All of the material wealth and riches made possible because of fictitious financial assets and the inflated values given to the stock of the major corporations shall cause them to go into extreme debt and lose all of their money. Moreover, all of these big businesses, companies, and corporations shall soon find themselves in a total and utterly unprofitable financial condition.

Praise יהוה! We have reached the point in our seminar discussion where we will read our foundation research Scripture for the final time with everything that our Father, יהוה has allowed us to receive. That being so, let us read Revelation, Chapter 16, verse 4:

"And the third angel or messenger of יהוה in the series of seven angels poured and gushed out his portion or share of sorrow upon all of the banks, financial institutions, insurance agencies, investments agencies, mortgage companies, etc. of America and the world. This includes the sources and supplies of desirable qualities; such as money, property, stocks in trade, trademarks, and assets that are fictitiously exaggerated and inflated by the major companies and corporations of America and the world in order for them to have a

greater value than they should. Nevertheless, all of these companies and corporations shall go into the red, which is extreme debt and eventually become totally and utterly financially unprofitable."

Praise יהוה!
