

The Seven Seals of The Apocalypse, Part 8

Praise יהוה! Praise יהוה בן יהוה! Above all, I must thank my Heavenly, Preeminent, and Eleemosynary Father, יהוה, for sending His Precious Son, יהוה בן יהוה, to give me the blessing of true life. After having been born into a world where the Light of יהוה waxes dim in the minds of the people, I have finally been blessed to see His Light shine abundantly in all of us.

This is a great feat on the part of יהוה בן יהוה, who has gone to great lengths to raise us, the children of Hiram. יהוה בן יהוה has offered Himself as the Sacrificial Lamb for us, so that we may have eternal life. יהוה בן יהוה has given us the keys to knowledge and foresight not only so we can understand His sacrifice, but also so we can perceive His judgment on the throne of righteousness. Praise יהוה!

Welcome, family, to the grand occasion of the *Twenty-Fourth Annual Feast of Tabernacles 6007*, the final, great universal festival for the year. This feast commemorates our dwelling in booths as we wandered in the wilderness. However, we have ceased “wandering” and are now dwelling in the *tabernacle* of the mind of יהוה בן יהוה forever. Also, welcome to the final series of *The Seven Seals of the Apocalypse, Part 8*.

This seminar shall resume with the sixth and seventh seals, but we must first recapitulate what we discovered in our last series, as it sets the premise upon which this seminar is based. *The Seven Seals of the Apocalypse, Part 7*, introduced יהוה בן יהוה coming to execute judgment in the earth. We learned that His judgment would be recognizable to the “conscious” mind by a commotion unlike any other commotion, and that will be unleashed throughout the whole world. Our facts revealed this event to be an *insurrection* in which the world’s regular civilians will defeat their governments and take control of their countries by violence and fighting in the streets.

Moreover, it was pointed out that יהוה בן יהוה would make the final determination of all people, separating those who will enjoy heaven from those who will be sent to hell for transgressing the laws of יהוה. In addition, we found out that the Judgment of יהוה would also be recognizable by the occurrence of many natural disasters.

These natural disasters will be happening throughout the world in drastic proportions, such as catastrophic earthquakes, blizzards, hurricanes, and sandstorms. These extreme weather conditions shall sweep the globe causing a great loss of life and widespread damage throughout the world.

The wrath of יהיה shall also demolish all commerce, manufacturing, and service industries. יהיה shall cause the failure of all financial transactions so that there will be no buying or selling, which will devastate and shut down all partnerships and corporations world wide.

The fury of Judgment Day shall result in the hardships of these companies, as well as, all employees involved, and the small nations of the world who depend economically and politically on the more powerful nations to support them shall suffer immensely. Even more the shock from these catastrophes will catapult all nations of the world to resort to killing off great numbers of people indiscriminately out of utter distress.

To add to that, the people whom the world has incessantly celebrated in the media for their various arts and professions, shall lose their status, reputation, and dignity to the temptation of doing wrong, and hence, be punished. They shall sink into moral corruption and immoral behavior, and show a lack of standards, which will take away everything they have accumulated. This brings us to the point where we shall resume in Revelation, Chapter 6, verses 14 through 17, which reads:

And the heaven departed as a scroll when it is rolled together; and every mountain and island were moved out of their places.

And the kings of the earth, and the great men, and the rich men, and the chief captains, and the mighty men, and every bondman, and every free man, hid themselves in the dens and in the rocks of the mountains;

And said to the mountains and rocks, Fall on us, and hide us from the face of him that sitteth on the throne, and from the wrath of the Lamb:

For the great day of his wrath is come; and who shall be able to stand?

Praise יהוה! As you can see, this reference Scripture uses a lot of metaphors and symbols to make its point. Thus, we cannot understand the magnitude of the Scripture as it is. Therefore, to start this seminar off, we will examine the *heaven*. As referenced in *Webster's Third New International Dictionary Unabridged*, copyright 1971, on pages 1046-1047, **heaven** is marked as "a condition of utmost comfort." This definition introduces the fact that the world's *condition of utmost comfort* shall **depart** during the judgment of יהוה. **Comfort**, is depicted in the *Bartlett's Roget's Thesaurus*, copyright 1996, on page 748, under the keyword *prosperity*, reference number 847.1, as "fortune, economic prosperity, and affluence." On this wise, it is rather clear that during His judgment, יהוה shall cause the world's fortune, economic prosperity, and affluence to **depart**.

Depart is the past tense verb form of **departed**, and as found in the aforementioned concordance, under Greek reference number 673, **depart** is

equivalent to the Greek word *apochorizo*, which means “to rend apart.” Consequently, this information shows that the “*heaven*,” the fortune, economic prosperity, and affluence that abound in high end society will be *rent* apart.

Furthermore, as verified in the *Cambridge Dictionary of the American Language*, copyright 2000, Computer Software, **rend** means “to break violently.” On the authority of the *Webster’s Third New International Dictionary Unabridged*, copyright 1971, on page 271, the word **break** means “to ruin financially: BANKRUPT; leave virtually without assets.” It is obvious from this information that the fortune, economic prosperity, and affluence of the world shall be ruined financially; thus, leaving them virtually without assets and, in the end, bankrupt. Moreover, all this devastation shall occur “**violently.**”

In accordance with *Webster’s New World Dictionary & Thesaurus*, copyright 1998, Computer Software, **violent**, the base of *violently*, means “caused by violence.” Thus, the utter destruction of the financial institutions of the world shall be *caused by violence*. *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 1507 defines **violence** as “abusive exercise of power.” Consequently, the fortune, economic prosperity, and affluence of the world shall be ruined financially, caused by

an *abusive exercise of power*.

Naturally, we must determine what this *abusive exercise of power* truly is. In the *Webster's Third New International Dictionary Unabridged*, copyright 1971, on page 8, **abusive** is determined as "fraudulent." **Fraudulent** is identified in the *Merriam Webster's 11th Collegiate Dictionary*, copyright 2000, Computer Software, and it means "based on fraud." Furthermore, **fraud**, in *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 541, is "a deception deliberately practiced to secure unfair or unlawful gain." Thus, we have proven that the fortune, economic prosperity, and affluence of the world shall be ruined financially--leaving the world's inhabitants without assets and bankrupt--caused by an *exercise of power* that is based on a *deception deliberately practiced* to *secure* unfair or unlawful *gain*.

So what is the *deception* that will be *deliberately practiced* in this *exercise of power*? Proceeding with research obtained from the *Merriam Webster's 11th Collegiate Dictionary*, copyright 2000, Computer Software, the word **deception** implies a "TRICK"; while in the same source, a **trick** represents an "artifice," and an **artifice** is "an ingenious device." Thus, the *exercise of power* that shall ruin the world financially, and leave its inhabitants bankrupt and without assets, will be *based on* an *ingenious*

device.

Now what is an *ingenious device*? As referenced in *The Synonym Finder*, by J. I. Rodale, copyright 1978, on page 573, **ingenious** is synonymous to “imaginative.” And according to the *Merriam Webster’s 11th Collegiate Dictionary*, copyright 2000, Computer Software, **imaginative** is “FALSE.” Therefore, we can deduce that the *exercise of power* that shall break the world’s finances will be *based on a false device*.

Once again, *The Synonym Finder*, by J. I. Rodale, copyright 1978, on page 289, equates a **device** to a “cabal.” *The Encarta Reference Library 2004*, copyright 1993-2003, Computer Software, confirms a **cabal** as “a group of plotters, particularly one formed for political purposes.” **Plotter**, from the same reference source, characterizes “somebody who makes secret plans, especially to do something subversive.” Even more, the word **subversive** is defined as “intended to overthrow a government.”

From the facts, we have obtained so far, the fortune, economic prosperity, and affluence of the world shall incur financial ruin--leaving the world’s inhabitants without assets and bankrupt--caused by an *exercise of power* that is *based on* the actions of a *false* group of people. This false group of people--who are presumably formed for political purposes, and

who supposedly make secret plans intending to overthrow a government--represents the “deception” that has been *deliberately practiced* to *secure* unfair or unlawful *gain*.

As validated in the *Encarta Reference Library 2004*, copyright 1993-2003, Computer Software, **deliberate** equates to “carefully thought out and done intentionally; slow, careful and methodical.” Accepting the documentation in *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 1073, **practice** means “to plot”; and **plot**, on page 1051, means “to conceive and arrange the action and incidents of.”

So far, it is becoming rather apparent that the actions and incidents of this *false* group of people--presumably formed for political purposes, and who supposedly make secret plans to overthrow a government--have been carefully thought out, as well as intentionally, slowly, and methodically conceived and arranged. This “deception,” which shall cause the world’s fortune, economic prosperity, and lavish affluence to crumble, will be the grounds upon which this *exercise of power* is based in order to *secure* unfair or unlawful *gain*.

On the authority of *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 1232, **secure** means “to get possession of.”

And in the *Merriam Webster's 11th Collegiate Dictionary*, copyright 2000, Computer Software, **gain** is equivalent to “resources acquired.” Referring back to *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 1162, **resources** are “the total means available for economic and political development, such as mineral wealth and labor.” In accord with the *Merriam Webster's 11th Collegiate Dictionary*, copyright 2000, Computer Software, **mineral** is “any of various naturally occurring homogeneous substances (coal, petroleum, or natural gas) obtained usually from the ground.”

Subsequently, we have proven that based on a *false* group of people who theoretically intend to overthrow a government--but whose actions and incidents are carefully conceived and methodically arranged--the world shall be left bankrupt, virtually without **any** assets, and financially ruined by the *exercise of power* to obtain wealth from the ground such as: coal, petroleum, or natural gas.

In agreement with the *Webster's Third New International Dictionary Unabridged*, copyright 1971, on page 795, **exercise** is defined as “use”; while on page 1778, **power** is “ability to wage war.” In essence, we have ascertained that someone will use their *ability to wage war* in order to possess the wealth from the ground such as: coal, petroleum, or natural gas.

However, they will base the use of their ability to wage war on a *false* group of people (e.g. Al Qaeda, Taliban, or Osama Bin Laden) who supposedly intend to overthrow a government when, in actuality, this group's actions and incidents will be carefully conceived and methodically arranged as a *deception*. Contrary to their purpose of obtaining prosperity, this war will leave the world decimated, that is, economically desolated, bankrupt, and left without any assets *...as a scroll when it is rolled together...*," which brings us to the continuation of our foundation Scripture.

This part of the Scripture gives the appearance of a metaphoric similarity, describing the economic prosperity of the world turning into financial ruin *as a scroll when it is rolled together*. Upon consultation with *The Synonym Finder*, by J. I. Rodale, copyright 1978, on page 68, the word **as** is synonymous to "by reason of." Therefore, the war to obtain coal, petroleum, or natural gas, which is deceitfully based on a false group of people intending to overthrow a government, will leave the world decimated, that is, economically desolated, bankrupt, and without any assets *by reason of a scroll*.

In accord with *Random House Webster's Unabridged Dictionary*, copyright 1999, Computer Software, a **scroll** is classified as "a roll." **Roll**, as a noun, is classified in the same source as "bankroll." On the other hand,

bankroll is defined in *The Encarta Reference Library 2004*, copyright 1993-2003, Computer Software as “a fund of money used to finance a project.” Consequently, the war to obtain coal, petroleum, or natural gas--fictionally based on a false group of people intending to overthrow a government--will leave the world in financial ruin, bankrupt, and without any assets *by reason of the fund of money used to finance this project* when it is **rolled together**.

Roll, in a verb form, is determined in *The Oxford Universal Dictionary*, copyright 1955, on pages 1748-1749, as “gather.” As delineated in the *Merriam Webster’s Collegiate Dictionary*, copyright 1999, on page 482, **gather** means “to effect the collection of (as tax).” And **together**, on page 1240, means “considered as a whole.” All things considered, the war to obtain coal, petroleum, or natural gas that is “falsely” cloaked under a group of people intending to overthrow a government, shall destroy the world’s finances and leave the people without assets and bankrupt by reason of the fund of money used to finance this project, which shall effect the collection of taxes as a whole. It takes money to wage a war, and that money shall come from the whole world’s everyday working citizens. The span of a “global” taxation, may seem overstated; however, the proof of such is found in Luke, Chapter 2, verse 1, which reads:

*And it came to pass in those days, that there went out a decree from Caesar Augustus, that **all the world** should be taxed.*

Praise יהיה! Our next point in Revelation, Chapter 6, verse 14, addresses what will happen when the whole world is taxed into poverty to fund a war to obtain coal, petroleum, or natural gas. Since, this war shall be deceitfully based on a false group of people who, it is said, intend to overthrow a government; and since this war will leave the world in financial ruin, bankrupt, and without any assets, will everyone act indifferent toward this issue, or will the people finally protest such prodigal behavior? To answer this question, let us refer to our foundation Scripture and pick up where we left off: “*...and every mountain and island were moved out of their places....*”

Taken from the *Webster's Third New International Dictionary Unabridged*, copyright 1971, on pages 1476-1477, the word **mountain** is determinative of “mount.” **Mount** in the same source, on page 1476, is the same as “bank, pawnbroker; a lending agency.” We have ascertained from this research that after the global taxation that shall shatter the world's economic structure to fund the war to obtain coal, petroleum, or natural gas, **every** bank, pawnbroker, and lending agency, in addition to every *island* shall be *moved out of their places*.

Let us now proceed with the facts to discern what every *island* represents. Upon consultation with *The Oxford Universal Dictionary*, copyright 1955, on page 1049, the word **island** is specified as “REFUGE.” Furthermore, as referenced in the *Random House Webster’s Unabridged Dictionary*, copyright 1999, Computer Software, a **refuge** is “anything to which one has recourse for relief.” In *The Synonym Finder*, by J. I. Rodale, copyright 1978, on page 997, **recourse** is tantamount to “backup.” And upon referral to the *Random House Webster’s Unabridged Dictionary*, copyright 1999, Computer Software, **relief** equates to “money, food, or other help given to those in poverty or need.”

It is blatantly obvious that due to the global taxation that shall fund the war to obtain coal, petroleum, or natural gas, which will stamp the world into financial ruin, not only will **every** bank, pawnbroker, and lending agency be shut down, but also the people of the earth shall be depleted of the means to support and sustain themselves. Most of all, there will be no help available from their governments regardless of the taxes that will be collected. This global imbalance shall cause **every** bank, pawnbroker, lending agency, and **every** backup supply of money, food, or other help for those who shall be in poverty to be *moved out of their places*. In case you do not believe that such a “grievous” plague can afflict the *entire* world as you

know it, then let us read Genesis, Chapter 41, verses 56 through 57.

*And the famine was **over all the face of the earth:** and Joseph opened all the storehouses, and sold unto the Egyptians; and the famine waxed sore in the land of Egypt.*

*And all countries came into Egypt to Joseph for to buy corn; because that the famine was so sore in **all lands.***

On this wise, the worldwide taxation that will fund the war to obtain coal, petroleum, or natural gas shall result in *famine* for money and food. This famine will doom the people economically, leaving them bankrupt and without assets--thereby, causing **every** bank, pawnbroker, and lending agency, as well as **every** resource of money and food to be ***moved out of their places.***

Standing on the authority of *The New Strong's Exhaustive Concordance of the Bible*, copyright 1990, Greek reference number 2795, the word **moved** is translated as *kineo*, which means "to stir." In agreement with *The Oxford Universal Dictionary*, copyright 1955, on page 2023, to **stir** is "to put into tumult." Taken from the *Random House Webster's Unabridged Dictionary*, copyright 1999, Computer Software, **put** means "to subject to the suffering of something." Thus, we can definitively assert that because the global taxation that will fund the war to obtain coal, petroleum,

or natural gas will leave the world bankrupt and without assets--the banks, pawnbrokers, and lending agencies, in addition to the backup supplies of money, food, and other things for the poverty stricken shall be *subjected to the suffering of tumult.*

Ascertaining further knowledge from the *Merriam Webster's Collegiate Dictionary*, copyright 1999, on pages 1271-1272, **tumult** is a "RIOT." In *The Oxford Universal Dictionary*, previously mentioned, a **riot** depicts "an outbreak of active lawlessness or disorder among the populace." Also, *The Encarta Reference Library 2004*, copyright 1993-2003, Computer Software defines **populace** as "ordinary people, as distinct from the political elite or the aristocracy"; and, furthermore, **riot** in the same source is "a public disturbance during which a group of angry people becomes noisy and out of control, often damaging property and acting violently."

Thus, we have shown beyond a reasonable doubt that the devastating bankruptcy and depletion of assets that shall overshadow the world as a result of global taxation to fund a war to "unlawfully" obtain the world's coal, petroleum, and natural gas resources, will cause ordinary people to riot. Their *riotous* behavior will be characterized by an *outbreak of active lawlessness and disorder*. It goes without saying that they will be *angry* because they will have no money and no food and, thus, become *noisy and*

out of control, damaging property and acting violently, which is in line with Ezekiel, Chapter 7, verses 23 through 25. And it reads:

Make a chain: for the land is full of bloody crimes, and the city is full of violence.

*Wherefore I will bring the **worst of the heathen**, and they shall possess their houses: I will also make the pomp of the strong to cease; and their holy places shall be defiled.*

Destruction cometh; and they shall seek peace, and there shall be none.

Upon reading these facts, we see that the “populace”--ordinary people--will react horribly to the fact that יהיה shall afflict the world with financial destruction, after all, they are “ordinary” people. However, how will the *political elite* and the *aristocracy*--those who are distinct from “ordinary” people--react? To find out, let us resume our journey with the next verse of the sixth seal, Revelation, Chapter 6, verse 15, which reads:

*And the **kings of the earth**, and the great men, and the rich men, and the chief captains, and the mighty men, and every bondman, and every free man, hid themselves in the dens and in the rocks of the mountains;*

So, whom do the **kings of the earth** represent? In this Scripture, *The New Strong's Exhaustive Concordance of the Bible*, copyright 1990, under Greek reference number 935, translates the word **kings** as *basileus*, which

means “a sovereign.” As defined in *Webster’s Third New International Dictionary Unabridged*, copyright 1971, on page 2179, a **sovereign** is illustrated as “the person wielding supreme political power in a political state.” This political state is of the *earth*.

Validated in *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 431, the **earth** symbolizes “worldly affairs and pursuits.” Thus, we can boldly proclaim that due to the public uprising that shall incur from worldwide bankruptcy, financial ruin, and depletion of assets from global taxation, the people who wield supreme political power in the political states of “worldly” affairs and “worldly” pursuits shall find themselves *hiding* in the *dens and rocks of the mountains*.

...and the great men, and the rich men, and the chief captains, and the mighty men, and every bondman, and every free man, hid themselves in the dens and in the rocks of the mountains; (Revelation 6:15)

Additionally, the **great** men and the **rich** men shall also seek shelter from this destitution in the same *dens and rocks of the mountains*. In accordance with the *Merriam Webster’s 11th Collegiate Dictionary*, copyright 2000, Computer Software, **great** is characterized as “NOBLE.” Who are the *noble*? On the authority of the *Random House Webster’s*

Unabridged Dictionary, copyright 1999, Computer Software, **noble** is defined as “constituting a hereditary class that has social or political status in a country.” **Hereditary** is classified as “passing naturally from parent to offspring through the genes. Hence, the *great* men are characterized as the people of the earth whose social or political status in a country passes from parent to offspring. These people are indicative of the kings and queens, princes and princesses, dukes and duchesses, lords, ladies, etc. They are those having heirs to the throne; but in the event of global taxation where they shall suffer bankruptcy, financial ruin, and depletion of assets, they shall find themselves hiding in the *dens and rocks* during the judgment of יהיה.

Furthermore, the **rich** men are a part of another group of people. According to the *Webster’s Third New International Dictionary Unabridged*, copyright 1971, on page 1951, the **rich** are those “abounding in natural wealth.” **Natural**, as illustrated in *Merriam Webster’s 11th Collegiate Dictionary*, copyright 2000, Computer Software, means “produced by nature”; and **wealth** in the same source is the “abundance of valuable resources.” Consequently, those men who *abound* in the abundance of valuable **resources** produced by nature--that is coal, petroleum, or natural gas, which is obtained from the ground--will also suffer from global taxation

to support a war to possess the very resources they abound in. Thereby, the *rich men* shall incur financial ruin, and be forced to hide in the *dens and rocks* from the wrath of יהוה during Judgment Day.

...and the chief captains, and the mighty men, and every bondman, and every free man, hid themselves in the dens and in the rocks of the mountains; (Revelation 6:15)

Moreover, the *chief captains* in all of their valor shall live in fear of this dreadful day as well. Referenced in *The Oxford Dictionary and Thesaurus*, copyright 1996, on pages 240-241, **chief** designates “the highest official.” Also, in the same source, a **captain** is distinctive of “a great soldier or strategist.” Up to this point, we can deduce that the highest officials among the great soldiers or strategists will be afraid in the judgment of יהוה. On page 1445, a great **soldier** is described as “a military commander of a specified ability.” In like manner, the *Random House Webster’s Unabridged Dictionary*, copyright 1999, Computer Software, overtly explains a **strategist** as “an expert in strategy, esp. in warfare”; while **strategy** is “the science or art of combining and employing the means of war in planning and directing large military movements and operations.”

We have since gone *over and beyond* to specify that the *chief captains* represent the highest officials among the military commanders,

especially those who are experts in the science or the art of combining and employing the means of war by planning and directing large military movements and operations. These are the people who know all there is to know about “mundane” warfare. However, these said individuals will have the fear of יהיה” scared into them at the time of this global taxation when they shall suffer bankruptcy, financial ruin, and depletion of assets, and find themselves seeking shelter in the *dens and rocks of the mountains*.

...and the mighty men, and every bondman, and every free man, hid themselves in the dens and in the rocks of the mountains; (Revelation 6:15)

As such is also the fate of *every mighty man, every bondman, and every free man*. Upon tracing the word **mighty** to its origin in *The New Strong’s Exhaustive Concordance of the Bible*, copyright 1990, reference number 1415, you will find that it translates into the Greek word *dunatos*, which means “capable.” **Capable** may seem to be an understatement for the word *mighty*, but according to *Merriam Webster’s Collegiate Dictionary*, copyright 1999, on page 168, it means “having legal right to own.” **Own** is found in the *Random House Webster’s Unabridged Dictionary*, copyright 1999, Computer Software, to mean “possess,” while **possess** is “to make (someone) holder as of property, etc”; **holder**, in the same source is

classified as “a person that rents and occupies land, a house, or the like, from another for a period of time; lessee.”

We have consequentially proven that every one who has the legal right to make others people renters or lessees and occupy land, houses, or the like, will retreat in absolute horror of the global taxation that shall cause them to be bankrupt, financially ruined, and virtually depleted of their assets. And as expected, they shall turn to the *dens and rocks of the mountains* along with the *bondman* and the *free man*.

As disclosed in *The New Strong's Exhaustive Concordance of the Bible*, copyright 1990, reference number 1401, the Greek word for **bondman** is *doulos*, this word reveals “a slave (lit. or fig., invol. [involuntary] or vol. [voluntary].” In conjunction with these facts, it seems that *bondmen* are involuntary or voluntary *slaves*. Question: Would anybody in their right mind “volunteer” to be a *slave*? As we identify what a *slave* is, then we will not only see **would** they volunteer, but that they **do**.

A **slave** is confirmed in *Webster's Third New International Dictionary Unabridged*, copyright 1971, on page 2139, as a “servant.” As verified in *Random House Webster's Unabridged Dictionary*, copyright 1999, Computer Software, a **servant** is depicted as “a person in the service of

another; a person employed by the government.” In addition, the **service** is, in the same reference, “the armed forces.”

From this information, it is becoming increasingly clear that people do in fact enter into *slavery* “voluntarily” and, as such, represent the people who are employed by their governments in the armed forces. Even more, Revelation 6:15 does not only reference those who will “volunteer” for *the armed forces* but also those who find themselves there “involuntarily”--meaning after being forced or drafted to be there.

Therefore, the **bondman**--those who are employed by the governments throughout the world to serve in the armed forces--shall, in spite of their war training, be “mortified” during the judgment of יְהוָה, because global taxation shall cause them to suffer bankruptcy, financial ruin, and depletion of assets. So they shall find themselves hiding in the *dens and rocks* during the judgment of יְהוָה along with the *free* man.

*...and every free man, hid themselves in the dens
and in the rocks of the mountains; (Revelation 6:15)*

According to *Merriam Webster's 11th Collegiate Dictionary*, copyright 2000, Computer Software, the **free** man is recognizable as a man “not bound, confined, or detained by force; capable of choosing for itself.”

Hence, the “**free**” **man** has the wherewithal to come and go as he pleases, as he is not bound, confined, or detained by force. He is one who is deceived into thinking he is **free** because he can choose certain things for himself. However, when the effects of this global taxation to fund the war to obtain the natural resources of the ground causes the *free* man to become bankrupt, financially decimated, and economically desolate, he will join the rest and *hide* in the *dens and rocks of the mountains*, but none of them shall have peace. Let us read, Jeremiah, Chapter 12, verse 12.

The spoilers are come upon all high places through the wilderness: for the sword of the Lord, יהוה , shall devour from the one end of the land even to the other end of the land: no flesh shall have peace.

Praise יהוה ! It is now time to expose all of these people’s attempt to be *hid* in the *dens and rocks of the mountains*. Taken from the *Webster’s Third New International Dictionary Unabridged*, copyright 1971, on page 1066, **hide** the past participle of **hid** means “to take shelter.” **Shelter**, is defined in the same reference, on page 2093, as “an area of safety.”

Given the facts we have presented, the lives of everyday citizens who can make choices for themselves (*the free man*), the people in the armed forces (*the bondman*), and those who have the right to make others renters

and lessees of property, such as land, houses, and the like (*the mighty man*) shall be ruined as a result of global taxation. Even more, bankruptcy, financial ruin, and virtual depletion of assets shall consume the politically elite (*kings of the earth*), the highest officials among the military commanders (*the chief captains*), and the class who passes down their social and political status from parent to child, such as kings and queens (*the great men*). On top of this, all those who abound in the coal, petroleum, and natural gas shall join them all to take safety in the *dens and rocks of the mountains* during the judgment of יְהוָה.

And the kings of the earth, and the great men, and the rich men, and the chief captains, and the mighty men, and every bondman, and every free man, hid themselves in the dens and in the rocks of the mountains;

As proven in *Random House Webster's Unabridged Dictionary*, copyright 1999, Computer Software, a **den** is classified as “a squalid place.” From *The American Heritage College Dictionary*, Third Edition, copyright 2000, on page 1319, **squalid** is considered “dirty and wretched, as from poverty.” This research is establishing that society as we know it today shall be brought down so low that all people, regardless of class or social status, will take safety in dirty, wretched places ruined from sheer poverty because of the bankruptcy and financial destruction they shall encounter. This greatly

impoverished people shall also find themselves taking safety in the *rocks of the mountains*.

Accepting the validity of *The Synonym Finder*, by J. I. Rodale, copyright 1978, on page 1047, the word **rock** is equivalent to “security.” Furthermore, the *Random House Webster’s Unabridged Dictionary*, copyright 1999, Computer Software, gives clarity on **security** and explains that it is “stocks and bonds.” *The Encarta Reference Library 2004*, copyright 1993-2003, Computer Software correlates **stock** as “the shares of a particular company or corporation”; and **bonds** as “interest-bearing certificate sold by corporations and governments to raise money for expansion or capital.”

This in turn explains that the people of the earth, from all classes that shall come to poverty, shall seek safety from bankruptcy and economic downfall in the *rocks of the mountains*--the banks holding their various shares from companies and corporations. It will be wishful-thinking to believe that they can “cash in” on the interest-bearing certificates from the same corporations and governments in hopes to pull themselves out of destitution. Since money will be drained from all their resources, they will not succeed, as determined by the judgment of יהיה .

יהוה [’s] judgment shall cause them such despair that the people of the earth shall ask for their stocks and bonds in different corporations, to **fall** on them, and **hide** them from the **face** of him that sitteth on the throne, and from the wrath of the Lamb, יהוהבן יהוה . According to the *Merriam Webster’s 11th Collegiate Dictionary*, copyright 2000, Computer Software, the word **fall** amounts to “ABATE”; and **abate** is referenced in the same source as “to reduce in degree or intensity; make less especially by way of relief.”

With respect to these facts, we can assert that the people of the earth will ask for the various shares they purchased from companies and corporations, and the interest-bearing certificates from the corporations and governments, to reduce the degree or intensity of the economic collapse resulting from global taxation. They will ask for their stocks and bonds so that they can lessen their impoverishment for at least “some” relief. They will hope for anything that will “hide” them from the **face** of יהוהבן יהוה , who sits on the throne to set judgment in the earth.

The **face** of יהוהבן יהוה , according to *The New Strong’s Exhaustive Concordance of the Bible*, copyright 1990, reference number 4383, is translated in Greek as *prosopon*, and it means “countenance.” Therefore, the men of the earth shall hide--take safety--from the *countenance* of

יְהוָה יִהְיֶה בְּיָהוּבָן יְהוָה. Verified in *Merriam Webster's 11th Collegiate Dictionary*, copyright 2000, Computer Software, **countenance** is “bearing.” **Bearing**, in the same source is “the manner in which one bears oneself.” In other words, they want to seek safety from the manner in which יְהוָה יִהְיֶה בְּיָהוּבָן shall bear himself in Judgment Day. Lastly, **bear** is found in *The Oxford Universal Dictionary*, copyright 1955, on page 158, as “to wield (power, sway, etc.).”

Consequently, the whole earth shall fear and seek shelter from the righteous and just manner in which יְהוָה יִהְיֶה בְּיָהוּבָן shall wield His power and sway, because His judgment shall not be favorable toward the wicked. In the event of global

taxation--where the world shall suffer bankruptcy, financial ruin, and depletion of assets--to fund a war to obtain coal, petroleum, and natural gas, the wicked shall seek to hide themselves from the judgment of יְהוָה, through stocks, bonds, or shares in various companies and corporations. Since they will not be able to acquire relief from these monetary resources, they shall be afraid of the power of יְהוָה יִהְיֶה בְּיָהוּבָן, for they will be ruined. Hence, when the *wrath* of יְהוָה יִהְיֶה בְּיָהוּבָן *is come* upon them they shall question, *Who shall be able to stand?* (Revelation 6:17).

For the great day of his wrath is come; and who shall

be able to stand?

Let us now review what we have attained throughout this seminar. Initially, we pointed out that all the fortune, economic prosperity, and affluence of the world shall be ruined financially, virtually leaving people without any assets and bankrupt. We further ascertained that someone will use their *ability to wage war* in order to possess the wealth from the ground such as: coal, petroleum, or natural gas. However, they will base their war on a *false* group of people (e.g. Al Qaeda, Taliban, or Osama Bin Laden) who supposedly intend to overthrow a government, when in actuality this group's actions and incidents will be carefully conceived and methodically arranged as a *deception*.

Contrary to their purpose of obtaining prosperity, this war will leave the world decimated, that is, economically desolated, bankrupt, and without any assets by reason of a “global” taxation. This taxation shall provide the fund that will be used to finance this war project, and effect the collection of taxes as a whole, resulting in **every** bank, pawnbroker, lending agency, and **every** backup supply of money, food, or other aid to be shut down.

To add to that, because there will be no way to support themselves, “ordinary” people shall resort to rioting. Out of pure anger, the people will outbreak in active lawlessness and disorder, become noisy and out of

control. Additionally, they will damage property and act violently.

Consequently, **all** classes of people shall find themselves in poverty-stricken, dirty, and wretched places hoping to get relief from their situations by cashing in on any stocks or bonds they may have so that they can reduce the intensity of the judgment of יהוה. Of course, this will be impossible. Subsequently, all these people shall wish to be hidden, or seek shelter, from the power that יהוה בן יהוה shall wield in exercising judgment upon the world, and they will question who shall be able to stand, which is the conclusion of the sixth seal. Therefore, let us read the seventh seal in Revelation, Chapter 8, verse 1 and 2:

*And when he had opened the seventh seal, there was silence in heaven about the space of half an hour.
And I saw the seven angels which stood before God;
and to them were given seven trumpets.*

When the seventh seal was opened there was **silence** in “heaven”--the world and all of its factions as we know it. As confirmed in the *Random House Webster’s Unabridged Dictionary*, copyright 1999, Computer Software, **silence** is descriptive of an “absence of expressed concern.” Therefore, the people of the earth shall adopt an absence of expressed concern for their condition for the *space of half an hour*.

As indicated in *The Encarta Reference Library 2004*, copyright 1993-2003, Computer Software **space** is “interval of time.” Thus, the people will have an absence of expressed concern for an interval of time of about *half an hour*. Of course, this does not mean they will be unworried for thirty minutes. Instead, *Merriam Webster’s 11th Collegiate Dictionary*, copyright 2000, Computer Software, shows **half** as “falling short of the full or complete thing.” On the other hand, **hour** is described in *The Encarta Reference Library 2004*, copyright 1993-2003, Computer Software, as “a period during which something particularly significant happens.”

In essence, the people of the world will lack expressed concern for their condition for an interval of time that falls short of the full or complete period during which something particularly significant shall happen. They will think that judgment is over when, in actuality, it will be *the calm before the storm*. Thereby, once this “particularly” significant period happens, the world’s concern shall resurface, as the angels of יהוה are given *seven trumpets* to continue judgment.

This concludes the series of *The Seven Seals of the Apocalypse*, I pray that the judgment of יהוה has been made unmistakably clear in your minds throughout this journey, and I pray that the protection of יהוה rests on you. Most of all, I thank my Father, יהוה and His Son, יהוה בן יהוה for

His merciful truth, and precious wisdom that shall feed our souls until He builds the Kingdom of Heaven that shall stand forever, and ever. Selah.
